In the event of any school-related accident or any other medical situation requiring treatment, we grant permission to any member of the Ava White Academy's staff to secure medical treatment, hospital services or laboratory tests for our child at our expense, and to hold harmless and indemnify the Ava White Academy and its staff, employees, volunteers and board members, of any and all costs and liability.

We grant permission for our child to appear in any media presentations for publicity purposes.

We agree to pay all late charges if tuition is not paid on time. We understand that tuition must be paid for our child to continue attending classes.
